RESOLUTION NO. 80-15

AMENDED RESOLUTION MAKING DETERMINATIONS APPROVING THE
FORMATION OF THE SQUIRE CANYON COMMUNITY SERVICES DISTRICT

The following resolution is now offered and read:

WHEREAS, a proposal for the formation of the Squire Canyon
Community Services District

was duly filed with the San Luis Obispo County Local Agency
Formation Commission, together with supporting documents required
by the rules of said Commission; and

WHEREAS, said proposal has been processed pursuant to the
provisions of the Government Code of the State of California as
determined by the Executive Officer to the best of his knowledge;
and

WHEREAS, at the times and in the form and manner provided
by law, said Executive Officer has given notice of public hearing
by this Commission upon said proposal; and

WHEREAS, said Executive Officer has reviewed said proposal
and prepared a report, including his recommendations thereon,
said proposal and report having been presented to and considered
by this Commission; and

WHEREAS, the public hearing by this Commission was held
upon the date and at the time and place specified in said Notice
of Public Hearing and in any subsequent hearings; and

WHEREAS, at such hearing this Commission heard and received all oral and written protests, objections, and evidence which were made, presented, or filed, and all persons present were given the opportunity to hear and be heard in respect to any matter relating to said proposal and report; and

WHEREAS, on November 20, 1980, this Commission adopted Resolution No. 80-13 conditionally approving the formation of the Squire Canyon Community Services District; and

WHEREAS, pursuant to Government Code Section 54799.1, this Commission has received a timely written request to amend Resolution No. 80-13, and this Commission has decided to act on said request for amendment without further notice and hearing.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED that the proposed formation of the Squire Canyon Community Services District of which the exterior boundaries as indicated on the map and legal description attached hereto and made a part of this resolution, representing inhabited territory, and being further identified in the files of the San Luis Obispo County Local Agency Formation Commission as file no. 10-R-80, be and the same is hereby APPROVED and designated as the Squire Canyon Community Services District by the San Luis Obispo County Local Agency Formation Commission, subject to the following conditions and terms:

1. That the boundary include the area as shown on Exhibit "A".
2. That the district's powers be limited to road construction and maintenance as set forth in Government Code Section 61600, subsections (j) and (k).
3. That at any future time said District Board desires to expand the District's services it must first obtain approval from LAFCo and the County Board of Supervisors.
4. That an application be received to detach the Squire Canyon area from County Service Area No. 12.
5. That, if at the hearing before the Board of Supervisors, the proponents submit a petition signed by at least 80 percent of the registered voters within the District and expressing their approval of the formation, no election be required pursuant to Government Code Section 61114.
6. That the number of members on the board of directors of the proposed Squire Canyon Community Services District shall be five (5).

BE IT FURTHER RESOLVED AND ORDERED that the Executive Officer of said Commission is hereby authorized and directed to mail certified copies of this resolution in the manner as provided by law.

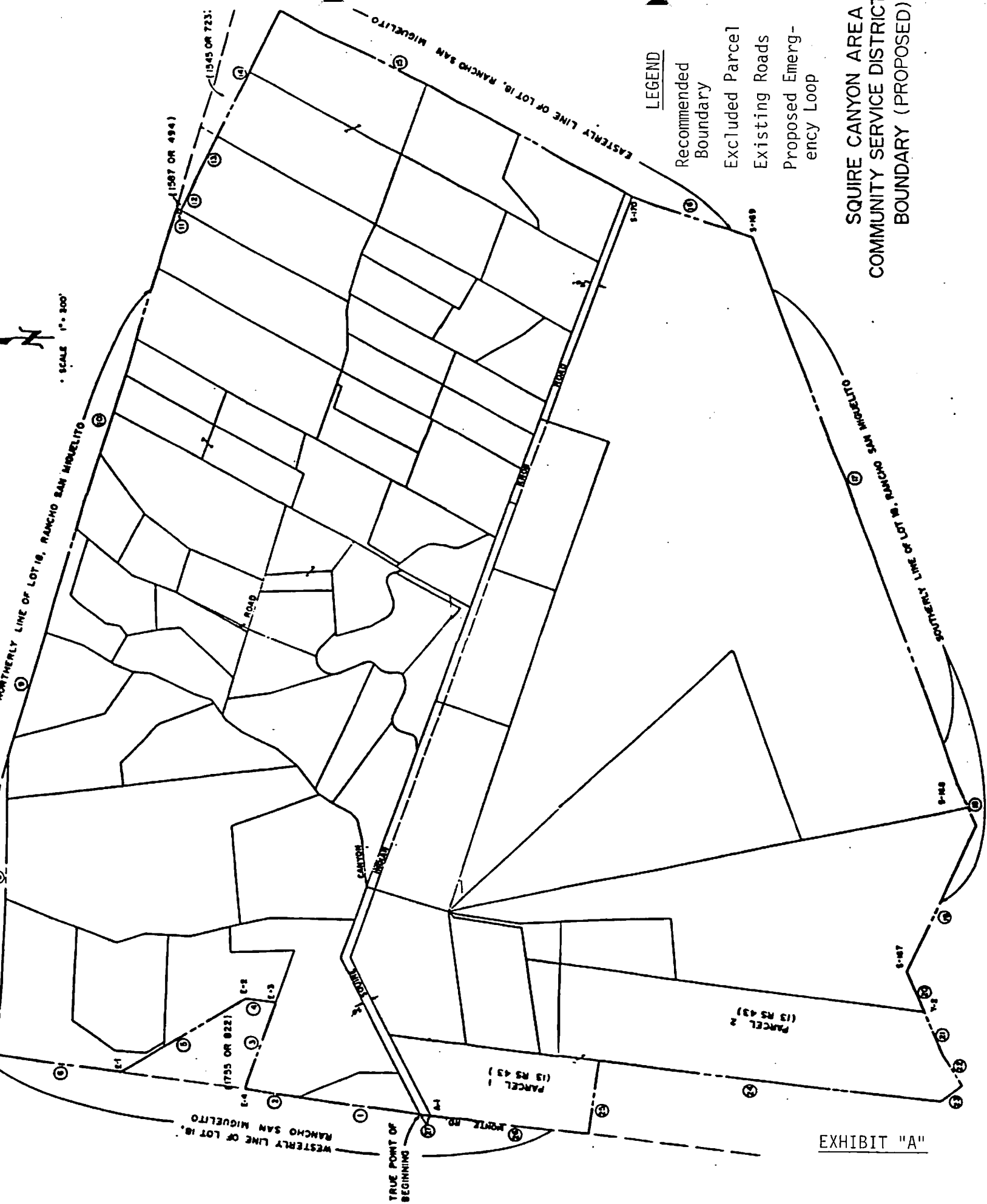
